- Included in the fee are the Preliminary Plan Review, First Submittal, Engineered Plan Review, As-builds Approvals, and Inspection Services.
- Review fees apply to each phase of subdivision.
- After 2 years plan must be resubmitted and are subject to applicable plan fees.
- Residential; \$250.00 fee plus \$10.00 per lot.
- Commercial & Industrial; \$300.00 flat rate.
- Public; case by case.
